

**The Mall at Partridge Creek Black Friday FREE Appetizer Promotion (“Promotion”)
Official Promotion Rules**

1. Eligibility:

Open to legal United States residents, 18 years of age or older as of the date of entry. This Promotion is void where prohibited by local, state or federal regulations.

2. Conditions to Receive Free Appetizer:

Promotion is being conducted from Friday, November 28, 2008 at 11:00 a.m. Eastern Standard Time and ends Friday, November 28, 2008 at 1:00 p.m. Eastern Standard Time (“Promotion Period”). To receive the free appetizer, you must do the following: Be seated at a Participating Restaurant (defined herein) during the Promotion Period. Any and all other menu items ordered by guest (s) at Participating Restaurants in addition to the one Free Appetizer will be at guests’ sole expense. Offer is valid while supplies last or until the end of the Promotion Period. A total of 100 Free Appetizers per Participating Restaurant (700 total) are available for the Promotion. Only one Free Appetizer per table during the Promotion Period. Free Appetizer is valid for dine-in guests only.
